If it is serious, my veterinarian shall be contacted first. If my veterinarian is unavailable, another vet shall be notified.

4. I authorize LuckyDogz, LLC to transport my dog to and from the facility or any other necessary location as needed.

5. I understand and agree that there are risks associated with my dogs attendance at Doggie Playdays. These risks include, but are not limited to, illness or injury.

6. I will keep my dogs vaccinations current at all times.

7. I, as the owner, agree to be solely responsible for any and all acts or behavior of my dog while in attendance at Lucky Dogz. If my dog becomes ill or is in need of any medical attention, I authorize Lucky Dogz to administer care and or engage the services of a veterinarian. I will be responsible for the charges incurred.
